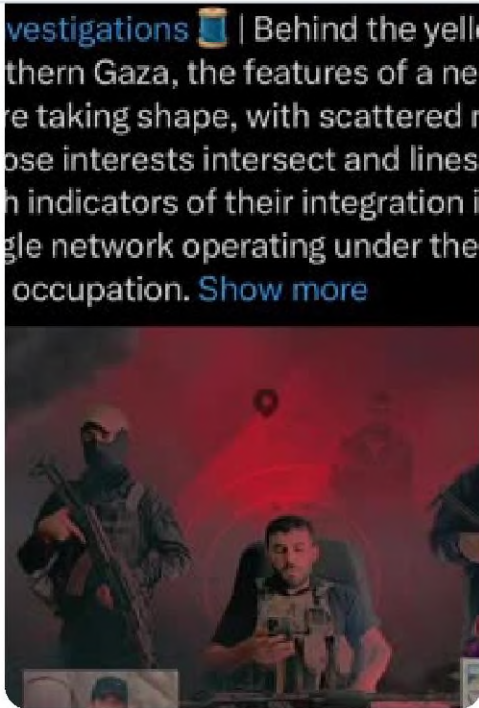

## Overview

This Privacy Policy explains how information about you is collected, used, and disclosed by TheTruthAboutIran.com. This Privacy Policy applies to information we collect when you use our websites, mobile sites, mobile applications, and other online services that link to this Privacy Policy (collectively, the "Sites") or when you otherwise interact with us.

We may change this Privacy Policy from time to time. If we make changes, we will notify you by revising the date at the top of the policy and, in some cases, we may provide you with additional notice (such as adding a statement to our homepage or sending you an email notification). We encourage you to review the Privacy Policy whenever you access the Sites to stay informed about our information practices and how you can help protect your privacy.

## Collection of Information

### Information You Provide to Us

We collect information you provide directly to us. For example, we collect information when you fill out a form, send us an email, sign up to receive email updates, sign a petition, sign up as a volunteer, create an account, schedule an event, participate in a contest or promotion, make a

purchase or contribution, communicate with us via third-party social media sites, request information, or otherwise communicate with us. The types of information we may collect include your name, email address, postal address, phone number, mobile number, credit card information, and other contact or identifying information you choose to provide.

#### Information We Collect Automatically When You Use the Sites

When you access or use our Sites, we automatically collect information about you, including:

- **Log Information:** We log details about your use of the Sites, such as browser type, access times, pages viewed, IP address, and the page you visited before navigating to our Sites.
- **Device Information:** We may collect details about the computer or mobile device you use to access our Sites, including the hardware model, operating system and version, unique device identifiers, and mobile network information.
- **Cookies and Tracking Technologies:** We use cookies and similar tracking technologies to gather information. Cookies are small data files stored on your device to enhance site functionality, analyze site usage, and customize your experience. Web beacons may also be used to track email interactions

### Information We Collect From Other Sources

We may also obtain information from other sources and combine it with the information we collect through our Sites. For example, if you create or log into your account through a social media site, we may access certain information from that site, such as your name and account details, consistent with the authorization procedures of the social media platform.

### Use of Information

We may use information about you to:

- Provide, maintain, and improve our Sites;
- Deliver information you request, process transactions, and send related details, such as confirmations and invoices;
- Communicate updates, technical notices, and security alerts;
- Respond to your inquiries and provide customer service;
- Send newsletters and information about issues, events, promotions, or services that may interest you;
- Connect you with other supporters and solicit volunteers;
- Monitor and analyze trends and usage to improve the Sites;
- Personalize content and deliver targeted advertisements;
- Process contest entries and rewards;
- Combine information from other sources to enhance your experience; and
- Fulfill any other purpose for which the information was provided.

By accessing or using the Sites, or providing information to us, you consent to the processing

and transfer of information within the United States and other countries with potentially different privacy laws.

### Sharing of Information

We may share your information as follows:

- With vendors and service providers who perform services on our behalf;
- To comply with applicable laws, regulations, or legal processes;
- To enforce our policies or protect the rights and safety of TheTruthAboutIran.com and others;
- As part of organizational changes, such as mergers or asset transfers; and
- With your consent or as otherwise disclosed to you.

Aggregated or anonymized information that does not directly identify you may also be shared.

### Online Petitions

If you sign an online petition, your name, city, state, and comments may be publicly displayed and shared with relevant stakeholders or the media.

## **YOUR PRIVACY RIGHTS**

California: Under California Law, California residents have the right to request in writing from businesses with whom they have an established business relationship, (a) a list of the categories of personal information, such as name, e-mail

and mailing address and the type of services provided to the customer, that a business has disclosed to third parties (including affiliates that are separate legal entities) during the immediately preceding calendar year for the third parties' direct marketing purposes and (b) the names and addresses of all such third parties. We will respond to such requests for information access within 30 days following receipt at the e-mail address stated above. Colorado residents are permitted to authorize another individual, acting on the consumer's behalf, to opt out of exchanges of personal information for money or other valuable consideration or processing for targeted advertising purposes, including through opt-out preference signals. We will respect an opt-out request received from a person so authorized to

act on your behalf, so long as we can authenticate your identity and the authorized agent's authority to act on your behalf.

To authenticate your request, we may require you to provide information to enable us to match that information to the records we maintain.

We will maintain and use de-identified information that does not constitute personal information in the de-identified form and will not attempt to re-identify such de-identified information except to the extent permitted under applicable law. We process personal information as described in this Policy.

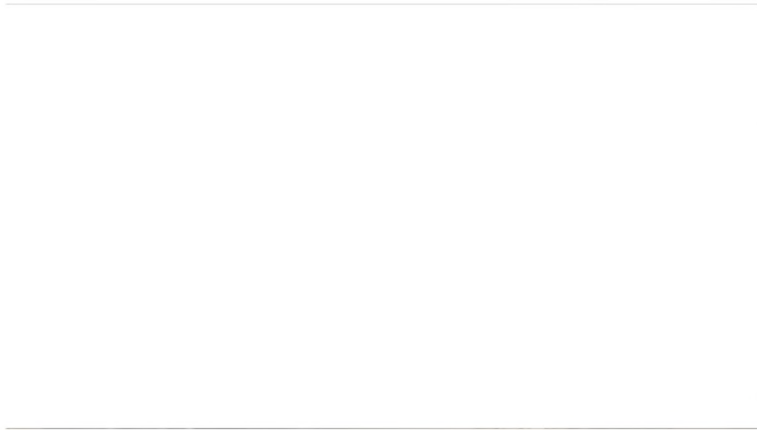
