Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC. ## **Appendix Response to Item 11**

Matthew Kohut will facilitate a one-time, half-day, in-person training on advanced strategic communication techniques for up to 10 members of the communications media relations staff of the Embassy of Canada in Washington, D.C., on October 20, 2025 or a date mutually arranged by the Parties. This Training will focus on advanced strategic communication skills, including: understanding what moves and sticks with audiences, segmenting US media audiences (elite/mass media, national/regional/local, red/blue, news/niche); understanding aggregators and social amplifiers; navigating cultural and domestic political norms and sensitivities; crafting and pitching stories for a wide range of media outlets; and managing crisis communications. Interactive elements will include reviewing recent pitches provided by the Embassy, recrafting pitches for widely varying audiences and outlets, and reviewing crisis communications challenges provided by the Embassy.
