In addition to a letter and attachment sent via electronic mail to Jeffrey Gilday, Registrant corrects its prior statements with respect to 9(a).

Financial Reporting Clarification

During preparation of this filing, the registrant discovered that not all historical invoices had been included in earlier draft disclosures. A complete summary of all amounts received from the foreign principal is attached to this letter as Exhibit 2. Any prior omissions were inadvertent and not intended to conceal income.

- In 2021, all work was virtual, and expenditures from funds received from Victoria consisted solely of general business overhead (salary, office rent, insurance, and supplies).
- From 2022 through 2025, expenditures consisted of the same general overhead, with some additional travel expenses. Registrant's practice was to receive payment from Victoria and exercise the discretion to make and cover its own travel costs from that payment.
- At no point has the registrant ever provided entertainment, gifts, meals, or other things of value to U.S. officials or other persons on behalf of the foreign principal.
- Registrant has never fundraised for the foreign principal or dispersed funds on behalf of the foreign principal.

The registrant regrets any inaccuracies or delays in financial reporting and submits this filing in a spirit of full cooperation and transparency.

The registrant also notes that certain delays in document collection and review occurred while its principal was dealing with serious health issues, including chronic leukemia and kidney complications, which affected the document collection.
