

Goran Samuel Pesic will act as principal lobbyist in a tiered lobbying strategy that delivers strategic senior level meetings, coordinated interagency outreach, and full regulatory compliance to advance IHI's U.S. certification objectives. The framework engages the executive, diplomatic, and technical levels of the U.S. government in sequence to secure White House-level alignment, interagency policy support, and programmatic progress toward Mass Source Approval for the F100/F110 engine programs.

The registrant will engage with the White House, the U.S. Department of State, and the U.S. Department of War to inform and advocate on matters related to IHI Corporation's proposed Mass Source Approval certification for the F100/F110 engine programs. Activities may include communicating policy considerations to White House and National Security Council staff, coordinating with State Department officials on diplomatic and defense-industrial issues, and engaging Department of War offices and service-level program officials on technical, acquisition, and certification matters. These efforts are intended to support U.S.-Japan defense industrial base cooperation and to align IHI's certification initiative with U.S. strategic, policy and programmatic priorities.
