

We are excited to have the opportunity to work with you. This letter of Agreement sets forth the parameters of the business relationship between Washington & Madison, LLC (referred to as "W&M"), and **Friends of Ambazonia INC**.

Washington & Madison, LLC offers premium boutique international services through an innovative, integrated service model that combines government relations and public relations, international legal services, and intelligence, security, and investigative services. This comprehensive approach enables us to meet the complex and evolving needs of international clients, particularly those operating across political, economic, and security landscapes.

Washington & Madison, LLC has a strategic alliance and works in close cooperation led by renown international attorney Mr. Arman Dabiri, head of the Law Offices of Arman Dabiri & Associates P.L.L.C., who has represented many foreign governments and international clients, most notably serving as long-time legal counsel to Libyan leader Muammar Al-Gaddafi. Mr. Dabiri's instrumental role in negotiating the \$2.7 billion Lockerbie settlement led to the lifting of U.N. and U.S. sanctions against Libya and the restoration of diplomatic relations with the United States. Background

Friends of Ambazonia Inc. is a U.S.-based, 501(c)(3) nonprofit advocacy organization dedicated to raising awareness and garnering international support for the independence of Ambazonia (formerly the Southern Cameroons) from Cameroon, focusing on diplomatic engagement, and amplifying the voices of the Ambazonian people through peaceful means. The Friends of Ambazonia, furthermore, is eager to advance U.S. geo-strategic interests in the Gulf of Guinea, and will coordinate closely with the U.S. government to be in alignment with U.S. foreign policy while pursuing its activities. Friends of Ambazonia Inc. is in full compliance with both U.S. and international law:

- Friends of Ambazonia INC. is **NOT** involved in directing, financing, or providing any material support to Ambazonian paramilitary organizations.
- Friends of Ambazonia INC. is **NOT** affiliated with any particular Ambazonian paramilitary organization.

Friends of Ambazonia INC. is **purely** an advocacy group consisting of U.S. citizens of Ambazonian origin who support Ambazonia. All funds of the organization go to political advocacy, media activities, and humanitarian activities.

Scope of Representation

This would be a bilateral contract which if signed and returned to us will establish a contract between W&M and Friends of Ambazonia INC. We will devote our best efforts to representing Friends of Ambazonia INC. and in doing so we will adhere strictly to both the legal and ethical obligations of our profession.

W&M will devote its best efforts to representing Friends of Ambazonia INC. and will always adhere strictly to the legal and ethical obligations governing our profession.

W&M will provide strategic counsel and facilitate engagement with appropriate members of the Executive and Legislative Branches of the United States Government, as well as relevant third-party stakeholders.

Specifically, W&M will facilitate and manage engagement with, among others:

- U.S. House and Senate leadership
- House Foreign Affairs Committee and Senate Foreign Relations Committee
- House and Senate Appropriations Committees
- House and Senate Armed Services Committees
- Relevant congressional caucuses and working groups
- Senior officials at the U.S. Department of State, National Security Council, and the White House
- Prominent religious, ethnic, and civil society organizations
- Media outlets, think tanks, and human rights organizations
- The Ambazonian and broader diaspora community in the United States
- U.S. companies and commercial interests

Anticipated activities include lobbying, advocacy, perception management, public relations, and the preparation and dissemination of informational and policy materials.

During the initial six-month engagement, W&M's primary objective will be to raise awareness of Ambazonian issues by facilitating direct meetings between the leadership of v and senior U.S. government officials. Our goal during this period is to demonstrate that Friends of Ambazonia INC. is the credible, serious, and principal interlocutor for U.S. policymakers on matters concerning Ambazonia.

Ambazonia is a resource-rich, geostrategic gateway in the Gulf of Guinea, offering significant strategic value to the United States. Accordingly, meaningful benefits could be realized through U.S. engagement on the Ambazonian issue. The principal obstacle to such engagement has been the fragmentation of Ambazonian political groups, compounded by inconsistent and often inadequate leadership.

To address this challenge, Washington & Madison (W&M) will support the Friends of Ambazonia INC. in working with the U.S. government to establish an **Ambazonian Shadow Government** composed of professional, credible, pragmatic, and pro-U.S. Ambazonians with whom the U.S. government can reliably engage and negotiate. This structure would prevent the U.S. government from being inundated with competing and duplicative appeals from multiple factions.

Friends of Ambazonia INC. will assist the U.S. government in identifying and vetting suitable individuals for inclusion in this body. Ambazonian independence—or, alternatively, any negotiated resolution to the Anglophone Crisis—cannot be achieved without a single, clearly identified Ambazonian organization that the U.S. government trusts and can rely upon as a legitimate interlocutor for negotiations between the parties.

W&M and Friends of Ambazonia INC. agree to comply with all applicable laws, including those under the Lobbying Disclosure Act (LDA), as amended, the Foreign Agents Registration Act (FARA) as amended, and any regulations and/or rules promulgated thereunder. W&M acknowledges and understands that W&M will be solely responsible for its own compliance with all registration and reporting obligations imposed by FARA on W&M in connection with the services performed under this Agreement.

Relationship and Terms of Engagement

Subject to the terms of this paragraph, W&M and Friends of Ambazonia INC. will enter into a six-month contract, subject to renewal. Friends of Ambazonia INC. will pay a monthly fee of \$6,000 USD for services provided from February 1st, 2026 to July 31st, 2026. This contract may be terminated with 30 days' notice provided on the first of the month prior to termination. Either party, without cause, may terminate this engagement with thirty (30) days prior written notice. Monthly fees will be billed in advance on the first of the month and due on or before the 15th day of each calendar month.

In addition, Friends of Ambazonia INC. will reimburse W&M for reasonable and necessary out-of-pocket items that W&M receives prior authorization for, and that exceed, \$1,000.00. Administrative costs (phone, nominal travel, administrative support) are included in the retainer.

Independent Contractor

The Parties acknowledge awareness and stated preference that this is an agreement for services as an independent contractor. The Parties will exert all manner of good faith and take all reasonable efforts to ensure performance and prevent repudiation by other parties connected with its activities which could affect its performance under this Agreement. Furthermore, as an independent contractor, W&M shall not be held liable for any breach or failure to perform under subsequent contracts entered into between Friends of Ambazonia INC. and any third Party.

It is further understood that W&M is retained by and has contracted with Friends of Ambazonia INC. only for the purpose(s) and to the extent set forth above, and that W&M is an independent contractor, and shall be free to provide services to such persons or corporations as W&M deems advisable so long as same does not create a conflict of interest.

General provisions

- a) No modification or waiver of this Agreement shall be binding unless in writing and signed by the parties hereto.

- b) Severability. If one or more of the provisions in this Agreement are deemed void by law, then the remaining provisions will continue in full force and effect.
- c) This Agreement, and all transactions contemplated hereby, shall be governed by, construed and enforced in accordance with the laws of the District of Columbia and the United States of America, without regard to its conflicts of laws provisions.
- d) Any dispute arising under, related to or concerning this Agreement shall be litigated exclusively in federal or state court of competent jurisdiction that is situated in the District of Columbia. In the event any legal action is necessary to enforce this Agreement, the prevailing party shall be able to recover any and all reasonable attorney fees and costs necessary to enforce this Agreement.
- e) During the term of this agreement and at all times thereafter, W&M shall not disclose confidential information related to Friends of Ambazonia INC., or to third parties, nor use confidential information for any purpose whatsoever except for the purpose of performing services on behalf of Friends of Ambazonia INC..
- f) W&M shall have sole responsibility for payment of all federal, State, and local taxes or contributions imposed or required under unemployment insurance, workmen's compensation, Social Security, and income tax laws and for filing all required tax forms with respect to any amounts paid by Friends of Ambazonia INC. hereunder and any amounts paid by W&M to its employees. W&M shall indemnify and hold Friends of Ambazonia INC. harmless against any claims or liability (including penalties) resulting from failure of W&M to pay such taxes or contributions, or failure of W&M to file any such tax forms.

In signing this letter and returning it to W&M, Friends of Ambazonia INC. will be indicating agreement to the fee schedule described herein and will be authorizing W&M to perform services according to the terms set forth herein.
