

Registrant has an oral agreement with Dr. Farzam Kamalabadi (acting in his capacity as Presidential Envoy for Botswana) to serve as a subcontractor to the Future Trends Group. Registrant will provide strategic consulting to align United States economic interests with development projects in Botswana. Registrant will likely receive a monthly retainer and is also eligible for a success fee upon the closure of specific funding or investment deals.

9. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Registrant will engage with U.S. government officials, including representatives from the Department of State, DFC, and Congressional offices, to advocate for U.S. investment in Botswana's mining and energy sectors. Registrant will also facilitate meetings between Botswana government representatives and U.S. private sector stakeholders to promote bilateral economic cooperation.
