The Government of Botswana	The registrant sought to build on North Carolina's formal cooperative relationship with the Government of Botswana, primarily through the U.S. National Guard State Partnership Program (SPP). Federal government contacts made, and reported below, were in support of the registrant's commercial/development efforts between Botswana and North Carolina government officials and (intended but not actual) businesses. The registrant anticipated earning professional fees on any investment deals made, but ceased activity before any investment deal was identified or made. This work developed as an offshoot of Fang Consulting LLC's commercial activities in Botswana and other foreign countries. Since April 2026, the registrant has refocused on private sector commercial activity .

Response to Item 12-Description

The Government of Botswana: The registrant contacted federal and North Carolina elected officials and staff to promote private U.S. economic investment (as part of North Carolina's pre-existing, formal cooperative relationship with the Government of Botswana, primarily through the U.S. National Guard State Partnership Program (SPP)). Additionally, the registrant interacted with the U.S. Embassy to Botswana regarding commercial matters, such as investment opportunities and seeking information on potential Botswana business partners.

Response to Item 14(a)-Description

The Government of Botswana: The registrant attempted to attract US investment to Botswana through commercial infrastructure and mining deals. That required taking some direction from the Presidential Envoy on Investment, Dr. Farzam Kamalabadi, and requesting meetings for him with US federal and nonfederal government officials. No compensation was offered or paid. Instead, the registrant intended to earn a commercial fee on any investment deal made, but none was made before termination.

Appendix
Response to Item 15(a)-Description

The Government of Botswana: While the registrant paid expenses for travel and lodging in Botswana and North Carolina, no funds were disbursed on behalf of the Government of Botswana. Instead, all expenditures made were consistent with commercial activity relating to potential US investments in Botswana and other purposes, such as travelling to/from the sole short form registrant's home in North Carolina. The registrant's primary business is commercial investment and dealmaking, not FARA-regulated activities.
