The Tourism Authority of Thailand, Chicago Office, operates solely to promote tourism to Thailand and serve as a tourist information resource. Our office's formal jurisdiction encompasses the sixteen states of Alaska, Arkansas, Illinois, Indiana, Iowa, Kansas, Louisiana, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, Oklahoma, South Dakota, and Wisconsin.

The Tourism Authority of Thailand is headquartered in Bangkok, Thailand, and is Thailand's national tourism organization under the Ministry of Sports and Tourism, which administers the TAT like a non-profit. Each of its international offices, including the Chicago office, receives funding from headquarters to support its individual operations and to hire local staff. The directors of its international offices, including Chicago, are sent from Thailand on 3-year appointments, and they direct a team of locally based staff.


