As for non-legal matters, the Registrant will be providing day-to-day advice and counsel to the foreign principal on matters involving the Department of State and the President of the United States, including advice on strengthening and advancing the current relationship for the benefit of the Venezuelan people. Also included are services focusing on the principal's future political campaign (i.e. running in the next presidential election in Venezuela). A main focus will be working on removing the sanctions.

Appendix Response to Item 8

Item 8: Describe fully the nature and method of performance of the above indicated agreement or understanding.

The agreement between the Registrant and Acting President Rodriguez is for the provision of legal representation and services, including actual legal and consulting services pertaining to pending litigation and future litigation, as well as the provision of political advice relative to the relationship between Acting President Rodriguez, the other branches of the Venezuelan government, and the U.S. Government, which includes counseling and advice relating to the lifting of sanctions, holding free and fair elections, negotiating/settling creditor claims (not limited to those in the U.S.) and strengthening and maintaining the overall relationship between the two countries. The agreement is verbal, but the registrant anticipates that there will be a written retainer agreement to follow in the coming days/weeks. As for fees, a retainer will be established in the Registrant's attorney trust account (California), and a separate retainer will be established for other (non-legal, but political and other advice) outside of a trust account for services rendered/to be rendered. The duration of both services (legal and non-legal) will not have a termination date, but based on actual need for services, and can be terminated at any time by either side.

Political activities will include communicating with U.S. cabinet members and executive members in the current and future administrations and negotiating on behalf of Acting President Rodriguez in her official and personal/unofficial capacity for the benefit of the principal and other government branches, as well as the Venezuelan people. This will include Registrant efforts to change/improve the laws, rules and procedures for a more fair and balanced relationship between the two countries. This will include influencing and promoting U.S.-Venezuela political, legal and economic policies. Activities will include research, negotiations, and public relations.
