



The registrant has been engaged by Soma Oil and Gas Ltd to provide strategic advisory, business development, investor relations, and representative services in furtherance of Soma Oil and Gas Ltd's commercial interests. The agreement concerns support for the company's upstream oil and gas activities, including its exploration interests, financing objectives, strategic partnerships, farm-out opportunities, and related commercial development.

The registrant will perform the agreement through direct advisory work, meetings, correspondence, telephone and video calls, introductions, presentations, document review, preparation and review of business materials, and related communications with relevant persons and entities. The registrant may communicate with potential investors, commercial counterparties, strategic partners, financial institutions, professional advisers, and U.S. government officials or offices where such communications are relevant to the foreign principal's commercial interests and are conducted in compliance with FARA.

Yes. Prior to registration, the registrant engaged in limited preliminary activity on behalf of Soma Oil and Gas Ltd. Specifically, during Africa Energy Week in Cape Town, South Africa, October 1st to October 3rd 2025, the registrant communicated with Andrew Rapp, Senior Advisor at the U.S. Department of Energy, and provided a presentation concerning Soma Oil and Gas Ltd, its commercial interests, and its upstream oil and gas activities. No money, fee, reimbursement, expense payment, thing of value, or other compensation was paid, offered, requested, or received in connection with this communication or the transmission of the presentation. Apart from this limited communication and transmission of the presentation, the registrant did not engage in other registrable activities on behalf of Soma Oil and Gas Ltd prior to registration.
