



This letter confirms the terms under which London Global Strategies will provide government and public relations services in the United States to the Secretariat of Economic Development, State of San Luis Potosí, México.

We will register as a foreign agent for you under the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 et seq.

Fees and Expenses

We agree to a fixed fee of USD375,000, inclusive of expenses. Such fee shall be due and payable upon execution of this Letter of Engagement. All payments shall be paid by international wire transfer in USD to the US bank account designated by me.

Term of Agreement

This Agreement shall be effective upon the date that it is signed by both parties. The Agreement is for a period of six (6) months and may be renewed in writing by mutual consent of both parties.

Termination

You have the right to terminate our representation at any time upon written notice, provided that we will be entitled to retain as fully earned the fixed fee noted above. We also have the right to withdraw from this representation upon written notice for any reason for which withdrawal is authorized or required by law.

Confidentiality

Each party will keep the other's confidential information in strict confidence, except as required by law, including but not limited to, FARA disclosure obligations.

Amendments

This Letter of Engagement may only be amended, modified, waived, or supplemented by an agreement in writing signed by both parties.
