Privacy Act Statement. The filing of this document is required for the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide the information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the FARA Unit in Washington, DC. Statements are also available online at the FARA Unit's webpage: <https://www.fara.gov>. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. The Attorney General also transmits a semi-annual report to Congress on the administration of the Act which lists the names of all agents registered under the Act and the foreign principals they represent. The individual provides strategic advisory and representational services on behalf of María Corina Machado Parisca in the United States. The individual advises the foreign principal on matters relating to U.S.-Venezuela relations, including aligning the foreign principal's strategy and vision for Venezuela with United States national security, democratic governance, and regional stability interests. The individual's activities may include strategic consulting; engagement and communications with officials of the United States Government and its agencies; outreach to international organizations, think tanks, civil society organizations, and other stakeholders; arranging and participating in meetings; providing policy analysis and recommendations; and facilitating dialogue and cooperation concerning democracy, human rights, energy security, and the peaceful democratic transition of Venezuela.
