There is not nor has there ever been any agreement between registrant and foreign principal, either verbal or in writing, to establish any relationship for representation as a foreign agent.

This registration is the result of advice from the FARA unit, sought out of an abundance of caution, following activity intended to benefit a private-sector client of registrant disclosed under the Lobbying Disclosure Act of 1995, but which activity the FARA unit advises could also be construed to benefit the foreign principal. No fees, compensation, nor anything else of value were exchanged.

9. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Registrant does not engage in nor propose to engage in any future activities on behalf of foreign principal. Registration is limited to a single past occurrence, and is taken out of an abundance of caution and desire for transparency. In that instance, Mr. Hodges, acting on behalf of a private-sector client, engaged in a clerical scheduling task which involved the private-sector client, the foreign principal, and the office of a Member of Congress. Mr. Hodges then attended the meeting between the client, the foreign principal, and the Member of Congress. At the meeting he spoke only in answer to a question from the Member of Congress, and did not advocate for or against any position or official action from any government official which would benefit the foreign principal. Neither Mr. Hodges nor registrant intended to benefit the foreign principal, and neither received anything of value from the foreign principal in exchange for this activity.
