Item 8: Describe fully the nature and method of performance of the above indicated agreement or understanding.

The registrant and the foreign principle reached an oral agreement and understanding on June 30, 2026. Pursuant to that understanding, the registrant will provide limited pro bono advisory, strategic communications, and outreach support beginning August 1, 2026. The anticipated activities include facilitating introductions, identifying potential experts and panelists, and connecting the foreign principle with relevant think tanks, organizations, and individuals to support its outreach efforts.

The arrangement was not established through a formal written contract or an exchange of correspondence between parties. A letter dated July 1, 2026, from the Institute of Regional Studies, Islamabad, acknowledging the registrant's willingness to provide advisory, strategic communications, and outreach support is being submitted as supporting documentation of the relationship.

The duration of the arrangement has not been specified and will continue only as mutually agreed upon by the parties. The registrant will not receive any fees, compensation, reimbursement, or expenses from the foreign principle in connection with this limited pro bono support.
