My dear Mr. Shadi:

We were extremely pleased to conclude an agreement with you Monday.

This letter is to formalize our understanding with signatures of both parties. Would you please sign two copies for our files?

It is understood that for the six-month period, January-June 1961, Charles von Loewenfeldt, Inc., will undertake a public relations program in the 13 western states in behalf of tourism to the U.A.R. The budget is Five Thousand Dollars (\$5000) with the provision of Five Hundred Dollars (\$500) per month for retainer and labor costs and the balance to be divided as required between mailing, production, radio-television, entertainment, and travel costs to be outlined in Addendum A to this letter.

The retainer fee of \$500 per month will be payable on the first of each month with the exception of June when it shall be payable on June 25, 1961. Production costs and other expenses incurred during June will be billed upon receipt of all bills.

We appreciate very much your indication of a hoped-for and greatly increased budget for the year to follow. We shall do all in our power to warrant your continuing confidence and we are certainly proud to be of service.

December 7, 1960

The United Arab Republic is taking many important steps and this move to build tourism from the West may prove to be one of the most significant.

Thank you very much for giving us this assignment.
