



Dear Mr. Goto:

The United States-Japan Trade Council is pleased that your organization, the Japan Trade Promotion Office, plans to continue as a sustaining and contributing member of our Council. We understand your support will consist of contributions not to exceed \$451,135.00 during our current fiscal year (April 1, 1975 to March 31, 1976), provided your financial situation permits such disbursements.

I am glad to confirm that these funds will be administered strictly in accordance with the Constitution and By-Laws of the United States-Japan Trade Council. - (d) Sponsorship of meetings with the press and conferences with other interested persons to discuss the United States-Japan trade and related problems;
- (e) Maintenance of close coordination with other organizations and associations having an interest in liberal United States foreign trade policies generally and in the United States-Japan trade particularly;


(f) Economic and statistical research on selected problems of significance to the trade between the two countries.

At the termination of the fiscal year (March 31, 1976) we shall present to you an accounting for all funds received and shall return any balance still remaining at that time.

You or any other qualified representative of the Japan Trade Promotion Office, may at any time inspect our Council's activities and accounting records in order to assure that your contributions are expended economically in pursuance of the above-listed objectives.

We appreciate the substantial support your organization has been giving the Council and are grateful for the confidence thus expressed in our organization. Recommendations and suggestions as to Council activities are welcome at any time.
