
The Embassy of Japan, 2520 Massachusetts Avenue, N.W., Washington, D.C. (hereinafter referred to as the "Embassy"), and Tanaka, Walders, & Ritger, Federal Bar Building West, 1819 H Street, N.W., Washington, D.C. (hereinafter referred to as the "Tanaka") have agreed as follows:

1. Tanaka shall provide a survey in the form of a written report to the Embassy.
2. The survey will cover the following subject:  
Gathering data on and analyzing major components of U.S. exports.
3. The report on the above will be furnished to the Embassy by March 31, 1979.
4. The Embassy shall pay U.S. ten thousand dollars (U.S.\$10,000) to Tanaka, for the above survey, upon receipt of the above report.
