


CONTRACT

The Embassy of Japan, 2520 Massachusetts Avenue, N.W., Washington, D.C. (hereinafter referred to as the "Embassy"), and Tanaka, Walders & Ritger, 1919 Pennsylvania Avenue, N.W., Washington, D.C. (hereinafter referred to as "Tanaka") have agreed as follows:


1. Tanaka shall provide the Embassy with legal and informational counseling services with respect to matters relating to U.S.-Japan trade relations.

2. The Embassy shall pay U.S. \$18,000 (Eighteen Thousand Dollars) as an annual retainer for the period April 1, 1983 through March 31, 1984.
